Town of Tisdale 2024 Drinking Water Quality and Compliance Annual Notice to Consumers

Introduction

Saskatchewan Ministry of Environment requires that at least once each year waterworks owners provide notification to consumers of the quality of water produced and supplied as well as information on the performance of the waterworks in submitting samples as required by a Minister's Order or Permit to Operate a waterworks. The following is a summary of the **Town of Tisdale** water quality and sample submission compliance record for the **January 1 to December 31**, **2024** *time period. This report was completed on* **April 9, 2025**. Readers should refer to Environment's Municipal Drinking Water Quality Monitoring Guidelines, November 2002, EPB 202 for more information on minimum sample submission requirements and the meaning of type of sample. Permit requirements for a specific waterworks may require more sampling than outlined in the department's monitoring guidelines. A minimum of 0.1 milligrams per litre (mg/L) free chlorine residual is required for water entering the distribution system. Tests are normally performed on a daily basis by the waterworks operator and are to be recorded in operation records. This data includes the number of free chlorine residual tests performed, the overall range of free chlorine residual (highest and lowest recorded values) and the number of tests and percentage of results not meeting the minimum requirement of 0.1 mg/L free chlorine residual.

Turbidity is a measure of water treatment efficiency. Turbidity measures "clarity" of the drinking water and is generally reported in Nephelometric Turbidity Units (NTU). All waterworks are required to monitor turbidity at the water treatment plant. The frequency of measurement varies from daily for small systems to continuous for larger waterworks.

Chemical - Health Category

All waterworks serving less than 5000 persons are required to submit water samples for SE's Chemical Health category once every 2 years.

The last sample for Chemical Health analysis was submitted on August 23, 2023. Sample results indicated that the provincial drinking water quality standards were not exceeded.

General Chemical

All waterworks serving less than 5000 persons are required to submit water samples for SE's General Chemical category once every two years if a ground water source.

The last sample for General Chemical analysis was submitted on April 23, 2024. Sample results indicated that the provincial drinking water quality standards were not exceeded.
